## **Autism Statement**

At LVS Hassocks we aim to develop practices and policies that promote and sustain the wellbeing of children and young people with autism.

We aim to offer support and training for staff, parents and other stakeholders to enable them to best meet the needs of children and young people with autism.

We aim to establish a consistent approach across all areas of our school community that enables all individuals with autism to learn and make progress.

We aim to ensure that our communication with all stakeholders is clear and appropriate.

We aim to ensure that our physical environment is responsive to the needs of children and young people with autism, and that we take account of the sensory needs and differences of individuals.

We aim to provide a range of experiences that enable interaction; promote social inclusion and independence; and support students with autism to reflect of their experiences.

We aim to empower our students to understand their autism and celebrate their difference.

We aim to provide on-going high quality staff development for all members of staff at LVS Hassocks.

We aim to develop and sustain a multi-disciplinary approach where professionals plan and work together to meet the needs of students with autism.

## **Aims**

The aims of this policy are to:

- Clarify the school's approach to drugs for staff, students, Governors, parents/carers and to clarify the legal requirements and responsibilities
- Clarify the school's approach to smoking and vaping
- Give guidance to staff on the school's drug and education programme
- Safeguard the health and safety of students and staff in our school
- Enable staff to manage drug related incidents properly

## **Terminology**

Definition of terms

The definition of a drug is:

A substance people take to change the way they feel, think or behave. (United Nations' Office on Drugs and Crime) For the purpose of this policy, the word 'drug' will be taken to mean drugs, forbidden substances and any substance that produces an intoxicating or hallucinating effect.

- All illegal drugs (those controlled by the Misuse of Drugs Act 1971)
- Misuse of over-the-counter and prescription medicines and so-called 'legal highs' including alcohol, tobacco, volatile substances (those that give off gas or vapour which can be inhaled), ketamine, khat and amyl nitrates (known as poppers)
- Drugs misused to enhance performance i.e. steroids
- Misuse of solvents and aerosols
- CBD oil and other variants

LVS Hassocks believes that the presence of unauthorised drugs in school is not acceptable. We want our school to be a safe place for us all to work, and the presence of unauthorised drugs represents a threat to our health and safety. LVS Hassocks has a zero-tolerance policy on the misuse of drugs, therefore all incidences of misuse will be investigated. We recognise that the use and abuse of drugs is a feature of our society and therefore have a thorough, relevant and supportive programme of drugs education in our PSHE programme.

## **Responsibilities:**

The Principal will:

- Ensure that staff and parents/carers are informed about this drugs policy via its publication on the website
- Ensure that the policy is implemented effectively
- Manage any drug related incidents
- Ensure that staff are given sufficient training, so that they can teach effectively about drugs, and handle any difficult issues with sensitivity
- Liaise with external agencies regarding the school drugs education programme
- Monitor the policy on a day-to-day basis, and report to Governors, when requested, on the effectiveness of the policy

The Governing body will:

- Designate a Governor with specific oversight of drugs education – this will be part of the Safeguarding Governors responsibilities.
- Establish general guidelines on drugs education
- Support the Principal in following these guidelines
- Liaise with local authorities and health organisations, so that the school's policy is in line with the best advice available

Drugs education should enable students to develop their knowledge, attitudes and understanding about drugs, and to appreciate the benefits of a healthy lifestyle, relating this to their own and other's actions. It should:

- Build on knowledge and understanding
- Provide accurate information and clarify misunderstanding
- Explore attitudes and values, and examine the risks and consequences of actions relating to drugs
- Develop students' interpersonal skills, their understanding of rules and laws, and their self-awareness and self-esteem
- Ensure that all children are taught about drugs in a consistent manner, following guidelines that have been agreed by Governors, staff and parents

LVS Hassocks regards drugs education as a whole school issue and believes that opportunities to teach about the importance of a healthy lifestyle occur naturally throughout the curriculum, but especially in science and PSHE /Lifeskills.

- Students will learn about visiting the doctor, visiting the chemist and the importance of medicines and their safe handling
- Students will learn that alcohol is the most widely used drug, and that its dangers can be overlooked. We will ensure that our students are aware of the risks associated with drinking, particularly if they are on medication.
- Students will learn that smoking is a minority habit and encourage them to consider its effects and risks. We will teach students about the potential addictive properties of vapes. We also teach students about the dangers of volatile substance abuse, because of the high risk of accidental death, especially for first-time and occasional abusers
- We aim to teach all students about drugs, however different their attainment levels and however diverse their requirements. We recognise that our students may be more vulnerable, that different communities have different attitudes towards drug abuse, and that some students may have drug-abusing parents
- Drugs education takes place during normal lesson time and will sometimes be supported by the school nurse or another health professional.

### **Drug Incidents**

- An incident involving unauthorised drugs in school is most likely to involve alcohol, tobacco, vaping or volatile substances rather than illegal drugs.
- The first priority is safety and first aid, i.e. calling the emergency services and placing unconscious people in the recovery position

- An intoxicated student does not represent a medical emergency, unless unconscious. Students suspected of being intoxicated from inhaling a volatile substance will be kept calm to avoid placing an intolerable strain on their heart.
- Any drug suspected of being illegal will be confiscated and stored securely, awaiting disposal; these precautions must be witnessed and recorded. Staff should not taste unknown or confiscated substances.
- Legal but unauthorised drugs or medicines will also be confiscated, and will be returned to parents; the school may arrange for the safe disposal of volatile substances
- Where a student is suspected of concealing an unauthorised drug staff are not permitted to carry out a personal search, but may search a student's bags, locker etc.
- The Principal will decide whether the police need to be called or whether the school will manage the incident internally
- A full record will be made of any incident
- The Principal will conduct an investigation into the nature and seriousness of any incident, in order to determine an appropriate response.

When an incident concerning unauthorised drugs has occurred in school, and a student is involved, we will inform the parents/carers and explain how we intend to respond to the incident.

### **Informing the Police**

Where any drugs, or substances believed to be drugs, are discovered, the Principal must be immediately informed. The sample will be sealed and stored in a secure location together with details of the date and time of the seizure and witnesses present. The police will be informed.

### **The role of parents/carers**

The school is well aware that the primary role in children's drugs education lies with parents. We wish to build a positive and supporting relationship with the parents/carers of our students, through mutual understanding, trust and co-operation. To promote this objective, we will:

- Inform parents/carers about the school substance misuse policy
- Answer any questions that parents/carers may have about the drugs education that their child receives in school
- Take seriously any issue which parents/carers raise with teachers or Governors about this policy, or about arrangements for drugs education in school
- Inform parents/carers about the best practice known with regard to drugs education, so that they can support the key messages being given to children at school

When an incident concerning unauthorised drugs has occurred in school, and a student is involved, we will inform the parents/carers and explain how we intend to respond to the incident.

Staff will be cautious about discharging a student to the care of an intoxicated adult, particularly when the adult intends driving the student home. The focus will be on the student's welfare and safety and staff will suggest an alternative arrangement. If the behaviour of an intoxicated adult repeatedly places a child at risk, or the adult becomes abusive or violent, staff should consider whether the circumstances of the case are serious enough to invoke child protection procedures and possibly the involvement of the police.

## **Sanctions**

Any response to a drug related incident will take into account all the relevant facts and circumstances available and information about the students(s) involved. All relevant facts and circumstances must be disclosed at the first opportunity to do so. Subsequent versions, submitted at a later date, may not be considered. Parents will always be invited to discuss the incident with the Principal and the possible sanction(s).

The decision to suspend or permanently exclude (end placement) will be the Principal's, following consultation with the Governors and at all times in accordance with the School's Exclusion Policy.

For the avoidance of doubt:

- A student on school premises intoxicated or under the influence of drugs will be suspended pending investigation.
- Any student selling or distributing drugs or otherwise actively encouraging their possession or consumption by others will be suspended pending investigation.
- Anyone caught possessing or consuming drugs whilst at school or otherwise under the School's jurisdiction (e.g. on school trips) will be suspended pending investigation.
- Where drugs are found on a student or in their belongings the student will be suspended pending investigation.

The School may take action in accordance with this policy where it becomes known that drug abuse is taking place outside school which may, as a result, bring the School's reputation into disrepute.

## **Smoking and Vaping**

LVS Hassocks operates a no smoking policy at all times. This includes the smoking of tobacco, or tobacco substitute devices or alternatives, such as e-cigarettes, APVs - Advanced Personal Vaporisers (vapes) - or any shisha devices, regardless of the absence of smoke, nicotine, tar or tobacco.

## **Possession**

Possession of tobacco, cigarette papers, E-liquid and smoking/vaping paraphernalia, such as lighters, matches and any vaping accessories also indicates culpability and the individual(s) will be subject to sanctions as determined appropriate by the school. The school reserves the right to carry out random personal and site searches for smoking/vaping paraphernalia. Refusal to be searched will be taken as an admission of guilt and/or an indication that the student has been using the paraphernalia to smoke, and the school may take appropriate action which will include disciplinary action. If caught in possession of smoking related material, this will be confiscated and handed to the Principal.

## **Action against those caught smoking on site (or on school trips)**

All students determined to have been smoking tobacco, using e-cigarettes, APVs, or a shisha device, on the LVS Hassocks site (or on a school trip) will be subject to sanctions. For a first offence, this will likely be a discussion with the parents to clearly signal the seriousness of the offence, although the school may apply an alternative sanction which may be more than this, if it considers it appropriate.
